The fee for a visit (6 nights) is \$2500.00. There is a \$500 non-refundable deposit required to book each week. If you are unable to make the trip for any reason, your deposit will be forfeit. Any amount paid beyond the deposit amount will be refunded or applied to future dates at your option.

Additional costs to be anticipated include transportation from the Lower 48 or elsewhere, round-trip fare with PenAir from Anchorage to McGrath and roundtrip fare from McGrath to Moore Creek with Redline Air. A one night accommodation in McGrath for the return trip layover is also required.

Here is a simple step-by-step guide to booking a trip to Moore Creek Mine:

1. Print out and completely fill out this signup agreement. Mail the fully completed forms and your deposit or payment in full to the address below. Be sure you read and understand all the forms before you mail them in! Make all checks out to Moore Creek Pay-To-Mine LLC.

2. At least 90 days in advance of your departure to Moore Creek, make the following reservations:

a. Your connections to Anchorage in time to make the AM departure flight on PenAir. Keep in mind that your return from Moore Creek could be a few hours late, or in extreme cases a day or two late due to weather delays. This would be a good time to consider staying a day or two in Anchorage to see the local area, or arrange a fishing charter, etc.

b. Your reservations with Peninsula Air (PenAir). Call 1-800-448-4226 to book your reservation. We have a special round trip rate with PenAir. To receive it, you must make your reservations by phone and mention you are with Moore Creek Mining. If you book online at the PenAir website you will not receive the discount.

c. Book your room for your one-night stay in McGrath. There are two options for the stay in McGrath. The Hotel McGrath Bed and Breakfast 907-524-3951, and Takusko House 907-524-3198. You can save money by rooming with another person. You can also save money by eating a meal just before leaving Moore Creek if you wish. Do not put this off to the last second as lodging options in McGrath are limited!

d. Mike Stewart with Redline Air in McGrath will be expecting you. We keep him informed as to group arrivals and departures. Mike usually takes credit card payment for the flight to Moore Creek when you arrive in McGrath. However, if you would like to arrange payment in advance or have any questions for Mike call 907-524-3733 or email him at redline@mcgrathalaska.net .

e. Your payment in full must be received by us no later than 60 days prior to your departure!

3. Moore Creek Pay-To-Mine LLC cannot control factors like delays due to weather, smoke from forest fires, or other unforeseen issues. Delays in arriving at the mine or leaving the mine are possible. Refunds will not be issued for days lost due to these issues that are beyond our control. We therefore highly recommend you contact your travel agent about the possibility of obtaining travel insurance. This insurance can be had for minimal cost and can protect you from extra expenses incurred due to these types of travel problems. Allowing for an extra day in Anchorage on the departure end of your trip is also a form of cheap insurance in case you experience any delays in leaving the mine. Booking tight connections from Bush Alaska to the Lower 48 often results in missed flights.

The one-night stay in McGrath on departure night helps alleviate possible weather issues on departure day. It also means you get extra time at the mine instead of just getting up and leaving early that morning. Plus, you get to experience a bit of small town Alaska by spending the night in McGrath. You will be able to get showered up and clean before proceeding on the Anchorage.

Moore Creek Pay-To-Mine LLC Gold Adventure Member Agreement

As the undersigned Moore Creek Pay-To-Mine Gold Adventure Member, I acknowledge that this is a contract between myself and Moore Creek Pay-To-Mine LLC (an Alaskan Limited Liability Company), hereafter referred to as MC PTM LLC. This contract concerns, but is not limited to, information provided to me about terms, conditions, services, responsibilities, and other pertinent information that relate to the ability to have access and ability to prospect and find gold, silver and any other valuable naturally occurring minerals at Moore Creek Mine in remote Western Alaska.

I understand that prospecting for gold and other valuable minerals is an activity with unknown and uncertain results. I acknowledge that MC PTM LLC has not promised in any form what results I may have prospecting and/ or recreational mining at the Moore Creek Mine. It is understood that after having paid the participation fee in full, signing these forms, and satisfying the various other requirements outlined in this agreement, I will have access to recreationally mine for placer gold by use of a metal detector, gold pan, dredge and/ or high banker sluice at Moore Creek Mine in remote Western Alaska during my allotted time. It is further understood that I will be entitled to keep all of the placer gold and mineral specimens that I separate from the gravel and soils at Moore Creek Mine by the aforementioned methods. I further acknowledge and understand that I have no ownership, specific area, or mining claim rights on any MC PTM LLC claim or property that I have access to under this agreement. My prospecting and access to MC PTM LLC claims or properties is strictly limited to the allotted time I have contracted and paid for.

Deposits & Cancellations: If for any reason, payment has not been received in full 60 days prior to the adventure start date, participation and access to MC PTM LLC property and claims may not be allowed and your reservation may be offered to someone else. It is your

responsibility to insure MC PTM LLC receives the funds more than 60 days in advance. In the event that you cancel or fail to participate in the trip, the deposit amount of is not refundable. Travel Insurance can help protect you and travel companies (if any) from unforeseen and unexpected circumstances. Contact you travel agent for specific details and cost of Travel Insurance.

Safety and Responsibility: Prospecting and recreational gold mining in remote Alaska at Moore Creek Mine is a very safe and enjoyable activity if done properly. Safety is our utmost concern and a satellite phone will be at Moore Creek Mine in case of any emergencies. It is important however, that each expedition member realize that there are inherent risks involved in prospecting for gold and minerals in remote areas in Alaska, as there are in many other outdoor activities. Individuals must be responsible for their own actions and accountable for their own decisions. To acknowledge this assumption or risk, each person going to Moore Creek Mine is required to read, understand and sign liability and medical release forms. MC PTM LLC is not responsible for any loss, damage or injury to persons or property however caused or for any costs of accommodations and associated services caused by weather, transportation problems, and other events beyond MC PTM LLC control. When necessary for the safety or comfort of our guests, MC PTM LLC has the right to cancel or make reasonable schedule changes.

What is Included: Moore Creek Mine accommodations in a comfortable tent camp with oversize cots, all food for meals and snacks, potable water for drinking and cooking, prospecting and recreational mining instruction and advice, and various recreational gold mining equipment such as high banker sluices, suction dredges, metal detectors, gold pans, shovels, picks, sieves and screens etc. The fuel and oil to run motorized equipment is provided. Availability of some equipment may be limited by unanticipated demands for the use of any one single type of equipment at one time or equipment failures. A satellite phone is kept on-site for emergencies.

What is Not Included: Air transportation is not included. Overnight accommodations and meals at the starting or ending point of your trip, fishing license(s) and tackle, or items of a personal nature are not included. In addition, you need to bring (furnish) your own sleeping bag.

Health: I understand and acknowledge that Moore Creek Mine is in a remote part of wilderness Alaska with little or no immediate medical support. I further acknowledge that recreational mining and prospecting requires physical exertion and effort. An inability to perform physical labor can have a direct impact on how much gold a person may find during their stay. MC PTM LLC cannot require expedition members to provide proof of health insurance, but it is strongly recommended to review your policy. MC PTM LLC cannot be expected to and will not assume payment liability for medical care or treatment of any kind.

Fax and E-mail Agreement Transmission: Facsimile (fax) transmission of a signed copy of this contract shall be the same as delivery of an original. A copy of this contract emailed to Moore Creek Pay-To-Mine LLC from the participant with the participants name typed at the end of the email shall be considered by both parties as the same as delivery of a signed original.

Venue: I understand that this agreement, any associated waivers, releases, and any other MC PTM LLC matters are drawn under and to be enforced under the laws of the State of Alaska.

Photos: I also understand and agree that MC PTM LLC or its assigns, retains the right to photograph my prospecting adventure at Moore Creek Mine and to use any photographs, videotapes, motion picture recordings, or any other record for publicity advertising.

Transportation: My Moore Creek Mine prospecting and recreational mining adventure officially begins and ends at Moore Creek Mine. Moore Creek Pay-To-Mine LLC does not include and is not responsible

for transportation to and from Moore Creek Mine, and I am personally responsible for all risks associated with this travel.

LIABILITY WAIVER AND RELEASE AGREEMENT

In consideration for my being permitted to participate in the activities of Moore Creek Pay-To-Mine LLC, I agree to the following Waiver and Release.

I acknowledge that prospecting and recreational mining at Moore Creek Mine in remote Western Alaska has inherent risks, hazards and dangers for anyone that cannot be eliminated, particularly in a remote wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATIONS:

1. Water hazards in wading and boating in streams, rivers and ponds, including drowning.
2. Walking in rugged country.
3. Encounters with wildlife.
4. Inclement weather conditions.
5. The risk of injury from operating recreational mining equipment.
6. The risk of injury from riding an All-Terrain Vehicle (ATV) or any vehicle used to transport people or equipment.
7. The risks of handling firearms and being near others that have firearms in their possession.
8. Physical exertion needed to participate in prospecting and recreational gold mining.
9. The lack of immediate medical care in case of an injury or sickness.
10. Injuries including burns caused by fire, hot liquids or food.
11. Transportation to Moore Creek Mine, including landing at a remote, potentially hazardous airstrip.

I understand the risks, hazards, and dangers as described above. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe that I have that good physical conditioning and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY PROSPECTING AND RECREATIONAL GOLD MINING AT MOORE CREEK MINE WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subrogees, hereby KNOWINGLY AND INTENTIONALLY WAVE AND RELEASE INDEMNITY AND HOLD HARMLESS MOORE CREEK MINE LLC, their directors, officers, agents, employees and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses including reasonable attorneys' fees which are related to, arise out of, or are in any way connected with my participation in this activity including , but not limited to NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of my damage loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, or equipment, whether such damage, loss, injury, paralysis or death results from negligence of Moore Creek Mine LLC or from some other cause. I, for myself, my heirs, my successors, executors and subrogees, further agree not to sue Moore Creek Mine LLC as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of prospecting and recreational gold mining.

This Waiver and Release is intended to be as broad and inclusive as is permitted by Alaska Law. If any part or provision of this waiver and release is held to be invalid or legally unenforceable for any reason, the remainder of this Waiver and Release shall not be affected thereby and shall remain valid and fully enforceable. I further agree that the venue for any legal proceeding shall be in Anchorage Alaska.
